Ordinance 882 was introduced by Council Member Plathe.

Motion by Council Member Vander Pol that the reading just had to be the final reading and the Council dispense with the statutory provision that this Ordinance be fully and distinctly read on three different days as provided by section 380.3 of the Code of Iowa.

CITY HALL REMODEL: Discussion was held regarding remodeling City Hall. Mulder and Plathe will put together a bid package so a bid letting can be held in July to allow for the remodel during winter months.

COUNCIL COMMITTEES: Plathe informed the Council of a road grader staff is not using and doesn't foresee the need to keep in inventory. It was the consensus of the Council to advertise and sell the road grader.

Vander Pol updated the Council on the Daycare's 28E Board upcoming meeting.

Oltmans informed the Council of the upcoming preconstruction meeting for Jefferson Ave and Division Street. He also reported work being completed on the Water Blow-off Valve project.

OTHER BUSINESS: There will be a special meeting on May 30 to have a public hearing and approve the Budget Amendment.

Oltmans updated the Council on chairs and tables being ordered for the Community Building.

The Council discussed updating the Community Building's rental agreement and deposit refund policy. Staff will draft a new agreement with terms to be approved by Council.
