Kelling has seven days from the date of the court order to abate the nuisance and if he doesn't, the City was granted permission to enter the property and abate the nuisance and assess all related expenses to Kelling.

Oltmans also updated the Council on legal actions taken to inspect the remaining abandoned and vacant properties on Park Street.

**FIRE STATION ADDITION/COMMUNITY BUILDING PROJECT:** Plathe reviewed quotes from Poppema Sikma for multiple updates to the community building.

**OTHER BUSINESS:** Oltmans informed the Council that NIPCO needs to do some work on the transmission lines and there will need to be two power outages. The outages planned are July 6 and July 21 from 11:00 PM – 5:00 AM.

Oltmans informed the Council the second candidate offered the Electric/Natural Gas position has also declined the position. Staff will advertise again in papers and at the colleges.
